Because of reporting lag, their most recent data is generally 2-3 years old. In most cases, state-level abortion facts are more current than the numbers reported by AGI or the CDC.

STATE-LEVEL DATA

Total Abortions (2015): 3,176

The Utah Department of Health reports that 3,176 abortions took place in Utah during 2015.

Total Abortions (2014): 2,948

The Utah Department of Health reports that 2,948 abortions took place in Utah during 2014.

The Centers for Disease Control (CDC) reports that 3,102 abortions took place in Utah during 2013. The table below compares Utah abortion totals by year.

SOCIAL MEDIA GRAPHICS:

In 2013, 5.7% of pregnancies in Utah ended in abortion. This number does not take into account miscarriages. It was arrived at by dividing the state abortion ratio by the sum of the abortion ratio plus 1,000. The abortion ratio is the number of abortions that occurred per 1,000 live births. The table below compares Utah abortion percentages by year.

Out-of-State Abortion Percentage (2013): 6.7%

The Centers for Disease Control (CDC) reports that 6.7% of the abortions that took place in Utah were performed on out-of-state residents.

GUTTMACHER DATA

Total Abortions (2014): 2,960

The Guttmacher Institute reports that 2,960 abortions took place in Utah during 2014. In 2011, there were 3,290 abortions reported—compared with 4,000 in 2008 and 3,630 in 2005.

Abortion Rate* (2014): 4.6

The Guttmacher Institute reports that the 2014 abortion rate for Utah was 4.6. In 2011, the abortion rate in Utah was 5.4. It was 6.7 in 2008, 6.4 in 2005, and 6.6 in 2000. The 2014 abortion rate across the entire United States was 14.6.

*The abortion rate is the number of abortions per 1,000 women aged 15-44 years.

Percentage of Pregnancies Ending in Abortion (2011): 5%

In 2011, 65,100 women in Utah became pregnant. 79% of these pregnancies resulted in live births and 5% in induced abortions. The remaining pregnancies ended in miscarriage.

Percentage of All U.S. Abortions (2014): 0.3%

In 2014, 0.3% of all U.S. abortions occurred in Utah.

Facilities That Perform Abortions (2011): 9

In 2011, the Guttmacher Institute reports that there were 9 abortion providers in Utah. There were 7 providers in 2008, 6 providers in 2005, and 4 providers in 2000.

State Abortion Restrictions (2016):

- A woman must receive state-directed counseling about abortion and then wait 72 hours before the abortion takes place.
- Public and private health insurance can only cover abortion in cases of life endangerment, rape, incest, fetal abnormality, or severe health complications.
- Health plans offered in the state's health exchange can only cover abortion in cases of life endangerment, rape, incest, fetal abnormality, or severe health complications.
- The parent of a minor must consent before an abortion can take place.
- Public funding is available for abortion only in cases of life endangerment, rape, incest, or severe health complications.
